APPLYING FOR NAMHO MEMBERSHIP

We do not issue an application form for membership but prospective members might wish to use this sheet to make sure they send us the required information.

According to the constitution:

4. *Membership of the Association shall comprise of:-*

FULL MEMBERS - Being acceptable organisations whose interests lie in the field of mining history.

AFFILIATE MEMBERS - Being other bodies interested in the aims and activities of "the Association".

5. *Each applicant for membership shall provide to the Secretary a curriculum vitae and, where appropriate, a copy of its constitution and membership list. Applications will be considered as provisional from the date on which they are received by the Secretary subject to verification of details and agreement by the Officers after consultation. Applications will be referred to the next following meeting of the Council for approval by a simple majority of Full Members represented. The Council shall decide whether an applicant should be a Full Member or an Affiliate Member, taking into account the wishes of the applicant.*

6. *Membership may be refused and the reason notified to the applicant accordingly.*
